IMPORTANT NOTICE

SALES & USE TAX RATE UPDATE FOR IBERVILLE PARISH AND THE CITY OF ST. GABRIEL

Please be advised that, effective January 1, 2010, all dealers must charge the 5.666% sales and use tax rate on all sales, leases, rentals, and repair transactions of tangible personal property that is delivered or consumed within the City of St. Gabriel Corporate Limits. The 5.666% sales and use tax rate also applies to the dealers that were identified as City of St. Gabriel Industrial Facilities (Column C) on the Iberville Parish Sales and Use Tax Report that went in effect on October 1, 2009.

This rate change is reflected on the 2010 Iberville Parish Sales and Use Tax Report by the removal of Column C and retaining Columns A (5.000%) and B (5.666%).

The sales and use tax rate for all other areas within Iberville Parish remains at 5.000%.

The breakdown of sales and use tax rates for Iberville Parish are the following:

Parishwide except City of St. Gabriel corporate limits (Column A - 5.000%)

- 3.000% Iberville Parish Council
- 2.000% Iberville Parish School Board

City of St. Gabriel corporate limits only (Column B - 5.666%)

- 1.000% St. Gabriel City Tax
- 2.666% Iberville Parish Council
- 2.000% Iberville Parish School Board

Taxpayers will be provided copies of the 2010 sales and use tax reports prior to January 2010 tax filing period. **Please do not use the enclosed sales and use tax report prior to January 2010 tax filing period.** Taxpayers who file their sales and use tax returns electronically will be provided one copy of the 2010 sales and use tax report for viewing purposes only. Please dispose of the old sales and use tax forms after the December 2009 tax filing period.

It is essential that all registers and sales tax software be properly programmed to calculate the new tax rates beginning January 1, 2010 for businesses located and delivering products and services within the corporate limits of The City of St. Gabriel.
